PRIVACY POLICY OF THE SITE

THE REASON FOR THIS NOTICE

This page describes the site's management with reference to personal data processing of users. This notice is given in accordance with <u>article 13 of Legislative Decree Number 196/2003 - Code regarding the protection of personal data</u> to those who interact with this website, accessible electronically at the address:

The information applies only to the website ristorantequattromori.it and not to other *websites* visited through the *links*. The information is based on Recommendation no. 2/2001 of the European authorities for the protection of personal data, gathered by the Group established by <u>article 29 of the European Directive number 95/46 / EC</u>, adopted on 17 May 2001 to establish the minimum requirements for the collection of personal data *on-line*, and, specifically, the modalities, duration and nature of the information that the holders of the processing must provide to users when they connect to web *pages*, whichever is the purpose of the connection. THE "HANDLER" OF THE PROCESSING

The data referring to identified or identifiable people may be processed after consultation with the site. The "handler" of the processing is **RISTORANTE 4 MORI SRL**, located in MILANO (MI), Largo Maria Callas n. 1 - ITALY.

PROCESSING SUPERVISOR

RISTORANTE 4 MORI SRL has been held responsible for the processing in accordance with <u>article 29</u> of the Code regarding the protection of personal data, as required for the technological part of the site's maintenance.

DATA PROCESSING

The processing related to the data on this web site takes place, as mentioned above, at MILANO (MI), Largo Maria Callas n. 1 and they are only handled by the technical staff entrusted with the processing. If necessary, the data related to the newsletter service can be handled by the staff of the agency which is responsible for the maintenance of the site's technological part, Massimo Abbondi Comunicazione Integrata (responsible for the processing in accordance with article 29 of the Code for the Protection of Personal Data), at the headquarters of the agency itself.

TYPES OF PROCESSED DATA

Data - During their normal operation, the computer systems and the software needed for this website's operation acquire some personal data whose transmission is implicit in the use of internet communication protocols. This information is not collected in order to be associated with identified people, but it could, by its nature, allow one to identify the users through elaborations and associations with some data held by third party. This data category includes IP addresses or domain names of computers used by users who connect to the site, the URI (Uniform Resource Identifier) notation addresses of requested resources, the

time of the request, the method used to submit the request to the server, the size of the file received in reply, the numerical code showing the status of the reply given by the *server* (successful, error, etc.) and other parameters regarding the operating system and the computer environment of the user. This data is only used to obtain anonymous statistical information about the site's use and to check its correct functioning; they are deleted immediately after processing. The data could be used to verify responsibility in case of hypothetical computer crimes against the website: currently, except for this possibility, the data concerning *web* contacts is not kept for more than seven days.

Data provided voluntarily by the user - The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this website entails the subsequent acquisition of the sender's address, which is necessary to respond to requests, as well as any other personal data included in the message. Specific information shall be progressively shown or displayed on web pages dedicated to particular services given upon request.

Cookies- This site uses only technical cookies for an optimal operation and third party cookies for anonymous tracking. For further information please refer to the <u>extended legislation about the use of cookies</u>.

OPTIONAL PROVISION OF DATA

Aside from the information specified about the navigation data, the user is free to provide personal data to request answers via email, product catalogue or newsletters, for material information or other communications. Failure to provide data may make it impossible to obtain the requested service. To be thorough it must be remembered that in some cases (not ordinary management of this site) news and information may be requested in accordance with article 157 of the Code concerning the protection of personal data, for the purpose of monitoring the processing of personal data. In these cases the answer is compulsory.

PROCESSING METHODS

Personal data is processed by automated tools only for the time, as strictly required to achieve the purpose for which they were collected. Specific security measures are observed to prevent the loss of data, illicit or incorrect uses and unauthorised access.

RIGHTS OF THE PARTIES CONCERNED

The subjects to whom the personal data refers to have the right to obtain confirmation of the existence of such data at any time and to know its content and origin, verify the accuracy or request integration or updating, or correction as per article 7 of Legislative Decree n° 196/2003). Pursuant to the same article, the interested parties have the right to request the deletion, transformation into anonymous form or blocking of data processed in violation of the law and in any case to object to the processing for legitimate reasons.
